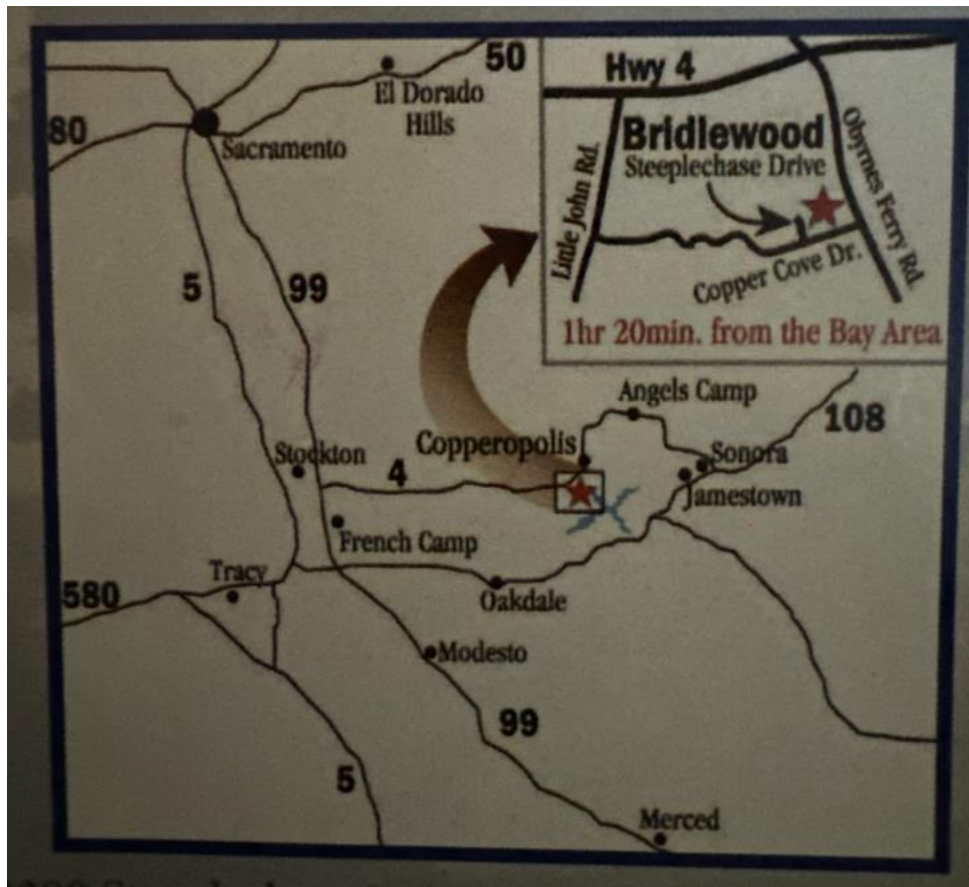

SHOW FEES:

Please note: Show Fees are per show. There are 2 shows per weekend.

Entry Fee- \$275, all divisions **\$250/show if entries for all 6 shows are
received and paid before April 1

Office Fee- \$26/entry

CA Drug Fee- \$14/horse for all horses on the grounds including those who are not entered in the show

NV Drug Fee- \$0

USAWE fee to record points- \$5

Friday Clinic- approximately \$175

USAWE Non-Member Fee- \$20/rider – not eligible for prizes or awards

Additional Fees:

Cattle Trial- July 28 only- \$65/trial. 2 trials will be offered. Intro riders can participate as a Schooling ride only per USAWE Rules

Late Fee, Incomplete entry, or Change Fee- \$50 per change, with show manager's approval

RV/LQ Fee (7 available)- CA \$25/night, includes water and electricity

Dry Camping- CA \$15/night NV-free

Stalls- CA \$100/box stall (13 available) or \$60/outdoor mare motel stall (9 available)- arrive after 12pm on Thursday and stay through Sunday. A communal tack room is available in the upper barn. No tack stalls are available. Early Arrival or Late Departure will incur additional cost and must be approved by the Facility Manager before arrival. Bring your own shavings.

Stalls- NV - \$60 uncovered pen or \$100 covered pen (limited number available, first come to reserve)

Haul-ins- CA \$25/day NV- free

All Horses must be recorded with USAWE: (<https://usawe.org/membership/recorded-horses/>) A one-time fee of \$30 per horse includes lifetime performance tracking.

GENERAL RULES & INFORMATION

CONDITIONS OF ENTRY

1. This show will be conducted and judged in accordance with the United States Rules for Working Equitation. The rules can be found at the following site: <https://usawe.org/rules>. It is the competitor's responsibility to read and understand the rules prior to the competition.
2. Management reserves the right to arrange for additional judges and to cancel, combine or amend any class, including but not limited to class awards, scheduling, show format, and location.
3. Management reserves the right to refuse, accept conditionally or to cancel any entries, disqualify riders or exhibitors, prohibit exhibition of entries, without claim to damages.
4. Show Management reserves the right to interpret all questions and conditions regarding, or arising out of, or incident to the show, without claims for damages or recourse of any kind. All questions not covered by these rules and regulations shall be decided by the Show Management and such determinations shall be final.
5. Owner/Agent/Participant agrees that every horse entered, or which they bring to the show grounds, will be subject to the rules of the Horse Show management. However, Show Management will, in no case, be responsible for any loss or damage that may occur to any horse entered or on the grounds, and it shall be a condition of entry that each exhibitor agrees to defend, indemnify, and hold harmless USAWE, any additional recognizing organizations, the facility at which the event is held (showgrounds), the horse show and its management, employees, volunteers and independent contractors for any loss or accident to his horse, horses or equipment which may occur.
6. All Owners and Exhibitors will be held responsible for any damage incurred by them, their agents, employees, or animals to stall buildings, animals, and other properties on the show grounds and shall be billed accordingly.
7. All bills for facility, veterinary, farrier services, bedding and feed are due and payable during the show. The management reserves the right to deduct any unpaid facility, veterinary, farrier, and feed bills from premium, stake or prize money, or refunds due to the exhibitor. Any exhibitor not meeting obligations to the facility, veterinarian, farrier, or feed supplier will be termed an undesirable exhibitor and entries from that exhibitor may not be accepted at subsequent events.
8. Competitors are responsible for all **INSURANCE** for themselves, employees, owners, horses, etc. Competitors are personally responsible for damages to third parties caused by themselves, their employees, agents, or horses. They are strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad and to keep the policy current.

ENTRIES - SCHEDULING - RIDING TIMES

9. Entries will be accepted on a first-come basis and must include all fees, membership and horse recording numbers, signatures, and payment. *Numbers will not be released until this process is complete. Entries without payment in full are still due in full.* Entries must be received by midnight of the Entry Closing date in order to avoid late fees. Entries submitted electronically and accepted are considered to be legal contracts and are subject to all of the rules of the show, including post/late entry fees. If the show has extended the courtesy of accepting a late or emailed entry, the responsible party will be liable to pay all class, office, stable and other fees. Withdrawing at any time will not excuse the responsible party from paying all of the applicable fees. Any exhibitor not meeting obligations to show management will be termed an undesirable exhibitor and entries from that exhibitor may not be accepted at subsequent events.
10. Management will close the show when it is full and place excess entries on a wait list. Show may fill before the closing date.
11. Late entries are allowed on a space available basis only and after all forms have been completed, signatures obtained, and fees paid. A late/post entry fee will be applied to all late entries. All change requests must be in writing. If the change is granted, the usual class and late entry fees will be charged.
12. Classes will be scheduled to accommodate the judges, riders and management. Rider scheduling preferences, if noted on the entry, will be indulged when possible per USAWE Rules.

SHOWGROUNDS- RV PARKING- DOGS

13. DOGS must be on leash at all times and owners must be able to provide proof of current rabies vaccination. Dog owners failing to comply with this rule may be subject to a minimum fine of \$100 per occurrence and owner may be refused entry into future shows. Any damage whatsoever that is attributed to the dog is the complete financial and any other responsibility of the owner of the dog. **DOGS ARE NOT ALLOWED ON THE GROUNDS AT BROKEN BIT RANCH, NOT EVEN IN YOUR TRAILER.**
14. Use of the warm-up arenas is limited to those who are entered in the show and, at the discretion of Show Management, will be restricted to those warming up for class(es) in progress when there is congestion.
15. RV hook-ups may be available; please contact the facility directly.
16. Dry camping is permitted.

STABLING - GROUNDS

17. Owner/Agent/Participant agrees that show management is merely providing stabling for the convenience of the participant and management and sponsoring organizations shall have no responsibility whatsoever for any injury, loss, damage, etc., as a result of using said stabling. Owner/Agent/Participant agrees to indemnify, defend, and hold Show Management, their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations harmless from any loss, damage or claims as a result of said use. **Owner/Agent/Participant assumes all care, custody, and control with regard to this use.**
18. The Stabling Request MUST be completed and paid for with entry. **Once ordered, there is no refund for stalls.** Stabling will be assigned in order of receipt of entry, with consideration for requests made on the entry. Fees apply whether the stall is used for a horse, tack, feed or grooming. There is no day use stabling available. Stabling is available from the Thursday prior to the start of the show at noon through the final day of the show. Additional days are subject to availability and may be requested on entry. Additional fees will be charged and are due upon arrival.
19. Grounds/Haul-in Fee will be charged for all horses not stabled. This fee applies to any horse brought onto the grounds, even if the horse remains on the horse trailer or is ridden or led onto the grounds.

20. No straw is allowed. Cost of repair for any damage or defacement of property will be charged to the Exhibitor. **EXHIBITOR IS RESPONSIBLE TO INSPECT STALL AND REPORT PRE-EXISTING DAMAGE PRIOR TO USING STALL.**

21. Please deposit all manure in the manure bins. Waste materials must be disposed of properly, in accordance with State law.

22. **NON-COMPETING HORSES.** Each non-competing horse must have a signed release, wear an assigned number, must observe the rules governing the use of the warm-up areas and must pay any required fees, including but not limited to office fees, stabling, haul-in and grounds fees. Any horse brought onto the grounds, including the parking lots, is subject to the rules of the show. This includes horses that never leave a horse trailer. Violations of this rule will result in double the fees due. Priority in availability, location and type of stabling will be given to competing horses.

23. Any balance due at the end of the show will be billed and subject to a billing fee. Payment must be made immediately upon receipt of the bill. Non-payment will result in the individual being turned in to the sponsoring organizations, in addition to all legal ramifications.

REFUNDS - CANCELLATIONS

24. **REFUND REQUESTS MUST BE IN WRITING AND SIGNED. Refunds for cancellations will only be made if the show fills and the spot can be filled from a wait list, regardless of the reason for the cancellation.** Vet letters and doctor letters will not be accepted. There will be no refund for stabling once it is ordered. There are no refunds for office fees even if the spot can be filled. There will be no refunds of any sort for same day scratches or no shows. These fees will be considered a contribution to the show and your signature on the entry verifies that this is understood as a condition of entry. These fees will not be applied to a future show.

25. Checks returned by the bank or credit cards that are refused will be assessed a minimum fee or the bank fees (whichever is higher) upon the first return and will not be run through a second time. A cashier's check or cash will be needed to clear the entry. Checks will be deposited the week before the show begins.

26. **CANCELLATION:** In the event that all or part of the competition is cancelled due to disease regulations, a storm, accident or any other emergency, the competition will not be responsible for refunding entry, stabling, office or any other fees.

AWARDS - PRIZE MONEY - FREESTYLES – MISCELLANEOUS

27. Show management reserves the right to amend award information at any time.

28. **MUSIC- MASTER'S LEVEL:** It is the responsibility of the exhibitor to have the cued music at the announcer's stand at the start of the ride and a representative at the stand to tell the announcer when to start and stop the music. A sound check will be conducted at each show; please make arrangements directly with the announcer. Exhibitors are responsible for retrieving their own music after the class.

STATE BORDER CROSSINGS:

29. The most recent information available on documents necessary for transporting horses across state lines is available at the following numbers: Nevada Department of Agriculture - (775) 688-1180 and California Department of Agriculture - (916) 654-1447. Be sure to ask if there are any prohibitions against feed as well.

JUNIORS

30. All minors/juniors must be always supervised by their parent/guardian or authorized agent while at or on the show grounds, whether riding or on foot. The parent/guardian or authorized agent shall assume all responsibility to protect juniors from any injury, damage, harm and/or loss and shall indemnify, defend and hold show management, its employees, independent contractors and volunteers, the facility at which the event is held, USAWE, and all affiliated organizations harmless therefrom.

31. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses, or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

ALL COMPETITORS

32. The dress and equipment rules will be in place from the moment of arrival on the grounds and will be in force for the duration of the show.

33. **Media Release Agreement:** I agree that as a condition of and in consideration of acceptance of entry, the competition may use or assign photographs, videos, audios, or other likenesses of me and/or my horse taken during the course of the competition for the promotion or benefit of the competition or sport. These likenesses shall not be used to advertise a product and they may not be used in any way to jeopardize amateur status. I hereby expressly waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or misappropriation.

BIOSECURITY

33. In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided. All exhibitors and their agents are responsible for the proper disposal of this waste. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.

34. All persons on the showgrounds must comply with facility and show management biosecurity guidelines and protocols.

35. If required, all trainers and exhibitors must provide thermometers for staff and require daily monitoring; regularly sanitize all equipment being handled; provide gloves and masks for staff and other personnel; restrict access to stabling areas to grooms, trainers, and essential personnel; comply with social distancing guidelines in effect; provide hand sanitizing stations in stable area; use gloves when using community wash racks and taps.

BIOSECURITY

By implementing the biosecurity measures below, you can minimize disease risk:

- Sanitize stalls before use
- Limit horse to horse contact
- Limit horse to human contact
- Avoid sharing of equipment, including tack, water buckets, brushes, wipe rags, etc.
- Avoid use of communal water troughs
- Avoid submerging end of water hoses in buckets
- Avoid tying horses to fences or gates
- Cover all feed and hay to prevent access by vermin, birds, or other animals
- Monitor your horse frequently for signs of disease during the event
- Immediately report any sick horse(s) to designated event official or veterinarian
